What is the purpose of this update?

Description of this fund

SuperLife¹⁰⁰ invests in growth assets. Designed for investors that are comfortable with the value of their investment fluctuating. Negative annual returns may occur once in every 2 – 4 years on average.

What are the risks of investing?

Risk indicator for SuperLife¹⁰⁰ Fund ¹

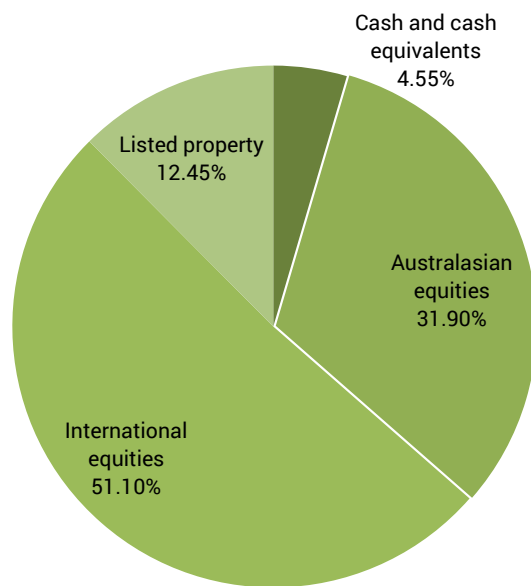
Example of how this applies to an investor

Jess had \$10,000 in the fund on 28 October 2016 and did not make any further contributions. On 31 December 2016, Jess received a return after fund charges were deducted of \$356 (that is 3.56% of her initial \$10,000). Jess paid other charges of \$2 (Jess received statements and other SuperLife communications electronically and was not charged the paper statements fee). This gives Jess a total return after tax of \$354 for the 2 months and 4 days.
