What is the purpose of this update?

This document tells you how Ethica has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Ethica is a socially responsible fund that invests in a balanced mix of income and growth assets. Excludes assets that do not meet ethical investment standards. Negative annual returns may occur once in every 5 - 7 years on average.

Total value of the fund: \$36,274,688

What are the risks of investing?

Example of how this applies to an investor

Jess had \$10,000 in the fund on 28 October 2016 and did not make any further contributions. On 30 June 2017, Jess received a return after fund charges were deducted of \$481 (that is 4.81% of her initial \$10,000). Jess paid other charges of \$8 (Jess received statements and other SuperLife communications electronically and was not charged the paper statements fee). This gives Jess a total return after tax of \$473 for the 8 months and 3 days.
