SuperLife^{Age Steps} - Age 60

For the quarter ended 31 March 2017.

This investment update was first made publicly available on 28 April 2017.

What is the purpose of this update?

This document tells you how SuperLife^{Age Steps} - Age 60 has performed and what fees were charged. The document will help you to compare the stage with funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this stage

SuperLife^{Age Steps} automatically adjusts the proportion of your investment in income and growth assets depending on your age. As you get older, the proportion of your investment in more volatile growth assets will be reduced, lowering the expected size of the ups and downs in the value of your investment. This option may be suitable if you are saving for retirement (assumed to be age 65), and assumes you will continue to invest your savings and spend them over your retirement period.

Your SuperLife^{Age Steps} - Age 60 investment will be allocated 42.5% to SuperLife^{Income} and 57.5% to SuperLife¹⁰⁰ (which are managed funds the stage invests in).

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the stage's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


Example of how this applies to an investor

Jess had \$10,000 in the stage on 28 October 2016 and did not make any further contributions. On 31 March 2017, Jess received a return after fund charges were deducted of \$575 (that is 5.75% of her initial \$10,000). Jess paid other charges of \$5 (Jess received statements and other SuperLife communications electronically and was not charged the paper statements fee). This gives Jess a total return after tax of \$570 for the 5 months and 4 days.

Notes

- Market index returns (as well as actual returns) have been used to complete the risk indicator as SuperLife^{Age Steps} – Age 60 invests in SuperLife^{Income} and SuperLife¹⁰⁰ (together with the NZ Cash Fund), which have not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of SuperLife^{Age Steps} – Age 60. The risk indicator for SuperLife^{Age Steps} – Age 60 uses 4 years and 7 months of market index returns for SuperLife^{Income} and SuperLife¹⁰⁰.
- 2 Estimates have been used to calculate the other management and administration charges. These estimates are based on our experience in respect of the other SuperLife managed investment schemes we manage and assume that the fund's actual investment mix will be consistent with the target investment mix set out in this fund update.
