What is the purpose of this update?

This document tells you how Ethica has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Ethica is a socially responsible fund that invests in a balanced mix of income and growth assets. Excludes assets that do not meet ethical investment standards. Negative annual returns may occur once in every 5-7 years on average.

Total value of the fund: \$38,833,703 The date the fund started: 28 October 2016

What are the risks of investing?

Risk indicator for Ethica¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

Jess had \$10,000 in the fund on 28 October 2016 and did not make any further contributions. On 30 September 2017, Jess received a return after fund charges were deducted of \$644 (that is 6.44% of her initial \$10,000). Jess paid other charges of \$11 (Jess received statements and other SuperLife communications electronically and was not charged the paper statements fee). This gives Jess a total return after tax of \$633 for the 11 months and 3 days.

Notes

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 4 years and 1 month of market index returns.
- Estimates have been used to calculate the other management and administration charges. These estimates are based on our experience in respect of the other SuperLife managed investment schemes we manage and assume that the fund's actual investment mix will be consistent with the target investment mix set out in this fund update.
