### Fund update for the quarter ended 30 June 2019

This fund update was first made publicly available on 26 July 2019.

# What is the purpose of this update?

This document tells you how SuperLife Conservative has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

# **Description of this fund**

Invests mostly in income assets. Designed for investors that want a conservative investment option. Negative annual returns may occur once in every 7-10 years on average.

# What are the risks of investing?

#### Risk indicator for SuperLife Conservative <sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a riskfree investment, and there are other risks that are not captured by this rating.



Small differences in fees and charges can have a big impact on your investment over the long term.

## Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$597 (that is 5.97% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total return after tax of \$585 for the year.

The fund's foreign currency exposure may be hedged to the New Zealand dollar, and hedging levels will vary between 0% and 110%. As at 30 June 2019, 69.75% of the fund's foreign currency exposure was hedged.
