SuperLife Age Steps - Age 50

Investment update for the quarter ended 31 December 2020

This investment update was first made publicly available on 16 February 2021.

What is the purpose of this update?

This document tells you how SuperLife Age Steps - Age 50 (the **stage**) has performed and what fees were charged. The document will help you to compare the stage with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this stage

SuperLife Age Steps automatically sets the proportion of your investment in income and growth assets based on your age. As you get older, the proportion of your investment in more volatile growth assets will be reduced, lowering the expected size of the ups and downs in the value of your investment. This option may be suitable if you are saving for retirement (assumed to be age 65), and assumes you will continue to invest your savings and spend them over your retirement period.

Your SuperLife Age Steps - Age 50 investment will be allocated 25.8% to income assets and 74.2% to growth assets.

What are the risks of investing?

Risk indicator for SuperLife Age Steps - Age 50¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the stage's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a riskfree investment, and there are other risks that are not captured by this rating. While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future stage updates.


How has the stage performed?


Example of how this applies to an investor

Jess had \$10,000 in the stage and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$530 (that is 5.30% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total return after tax of \$518 for the year.

Material changes

There have been no material changes to the nature of SuperLife Invest, the investment objectives and strategy of the stage, or the management of the scheme over the quarter ended 31 December 2020.

Notes

- Market index returns (as well as actual returns) have been used to complete the risk indicator as SuperLife Age Steps Age 50 invests in SuperLife Income and SuperLife High Growth, which have not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of SuperLife Age Steps Age 50. The risk indicator for SuperLife Age Steps Age 50 uses 10 months of market index returns.
- 2 We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges.
- 3 The administration fee is stated net of an income tax deduction applied in calculating your PIE tax payable (the deduction is paid to us). The relevant gross fee is calculated using your PIR.
