What is the purpose of this update?

The Asia Pacific Fund invests in the Smartshares Exchange Traded Funds' Smartshares Asia Pacific ETF.

What are the risks of investing?

Risk indicator for the Asia Pacific Fund¹


How has the fund performed?

GST is included in the fund charges set out above.


Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$248 (that is -2.48% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total loss after tax of -\$260 for the year.

Material changes

There have been no material changes to the nature of SuperLife Invest, the investment objectives and strategy of the fund, or the management of the scheme over the quarter ended 31 March 2020.

Notes

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 1 year and 7 months of market index returns.
- 2 The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
- 3 The Smartshares Asia Pacific ETF is also managed by Smartshares. As a result, the table lists the individual assets of the Smartshares Asia Pacific ETF as if they were individual assets directly held by the fund.
