## Fund update for the guarter ended 31 March 2020

## What is the purpose of this update?

This document tells you how the NZ Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this fund**

The NZ Shares Fund is designed to provide a return (after tax, fees and other expenses) that reflects the after-tax return on the New Zealand share market.

## What are the risks of investing?

#### Risk indicator for the NZ Shares Fund<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.




## Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$1,187 (that is - 11.87% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total loss after tax of -\$1,199 for the year.

#### Material changes

There have been no material changes to the nature of SuperLife Invest, the investment objectives and strategy of the fund, or the management of the scheme over the quarter ended 31 March 2020.

#### **Notes**

1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 1 year and 7 months of market index returns.
