#### Fund update for the quarter ended 30 June 2021

This fund update was first made publicly available on 21 July 2021.

# What is the purpose of this update?

This document tells you how the SuperLife Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

# **Description of this fund**

Invests mostly in growth assets and designed for investors that want a growth investment option. Negative annual returns may occur once in every 3-5 years on average.

# What are the risks of investing?

#### Risk indicator for the SuperLife Growth Fund<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


# How has the fund performed?

# Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$2,273 (that is 22.73% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total return after tax of \$2,261 for the year.

#### **Currency hedging**

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 76%. The actual hedging level can be anywhere in the 0% - 120% range. As at 30 June 2021, 75.27% of the fund's foreign currency exposure was hedged.

#### **Notes**

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 4 months of market index returns.
- 2 We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges.
- The administration fee in the year to 31 March 2021 is stated net of an income tax deduction that was applied in calculating your PIE tax payable (the deduction was paid to us). On 1 April 2021, we stopped doing this this means that if your prescribed investor rate is 10.5%, 17.5% or 28%, the total fee you now pay us will be lower.
