

# SuperLife Invest

## Overseas Shares Fund

This is a replacement fund update dated 24 April 2023, which replaces the previous fund update dated 3 May 2021. The market index return data in the "How has the fund performed?" section, including the annual return graph, has been updated to show correct market index returns over the relevant periods. In previous fund updates, the market index annual return data was calculated incorrectly.

### Fund update for the quarter ended 31 March 2021

This fund update was first made publicly available on 24 April 2023.

### What is the purpose of this update?

This document tells you how the Overseas Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

Invests in international shares and designed to reflect the return (before tax, fees and other expenses) on the international share markets of developed economies.

### What are the risks of investing?

#### Risk indicator for the Overseas Shares Fund<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

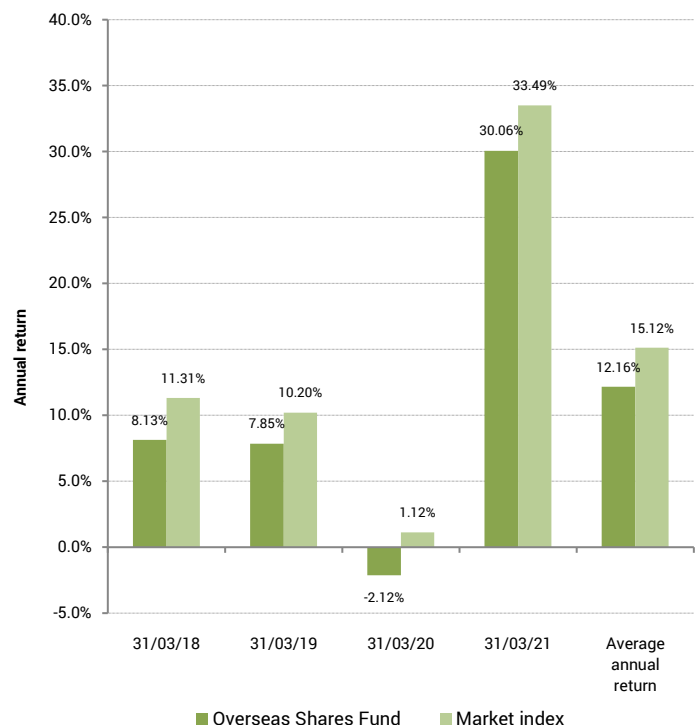

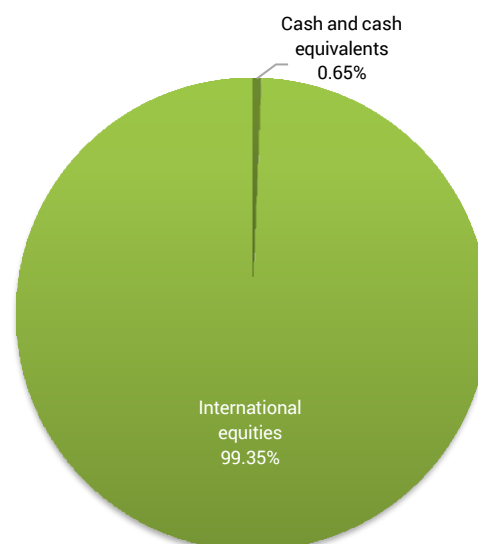
### Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$3,006 (that is 30.06% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total return after tax of \$2,994 for the year.

## Notes

- Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 7 months of market index returns.
- We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges.
- The administration fee in the year to 31 March 2021 is stated net of an income tax deduction that was applied in calculating your PIE tax payable (the deduction was paid to us). On 1 April 2021, we stopped doing this – this means that if your prescribed investor rate is 10.5%, 17.5% or 28%, the total fee you will now pay us will be lower.
- The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
