What is the purpose of this update?

This document tells you how the Australian Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests in Australian shares and is designed to reflect the return (before tax, fees and other expenses) of the Australian share market.

What are the risks of investing?

Risk indicator for the Australian Shares Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets

goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

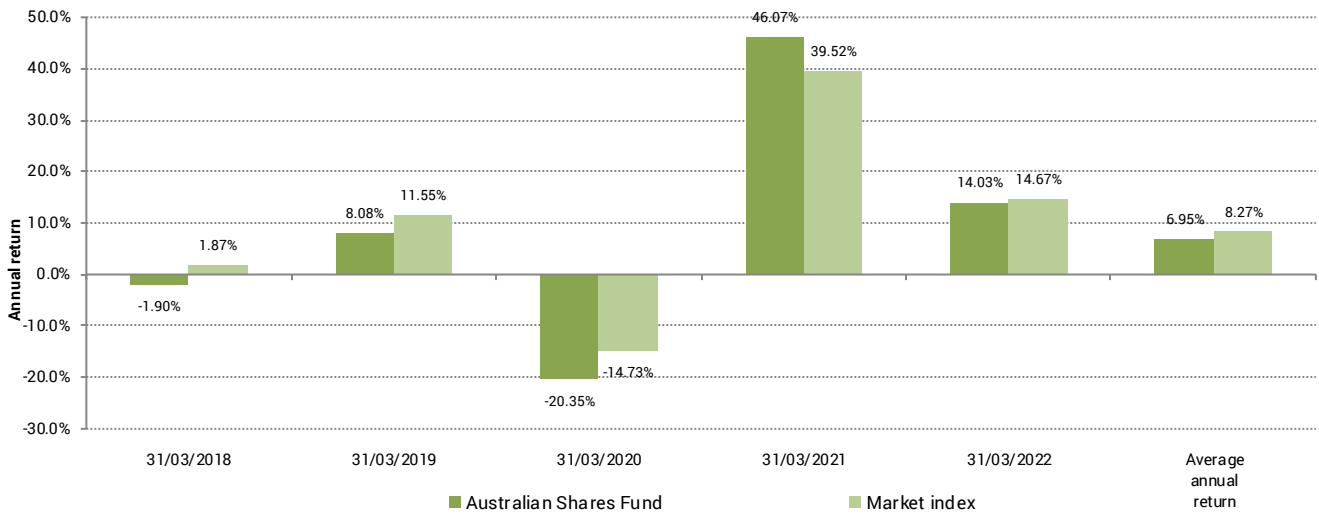
How has the fund performed?

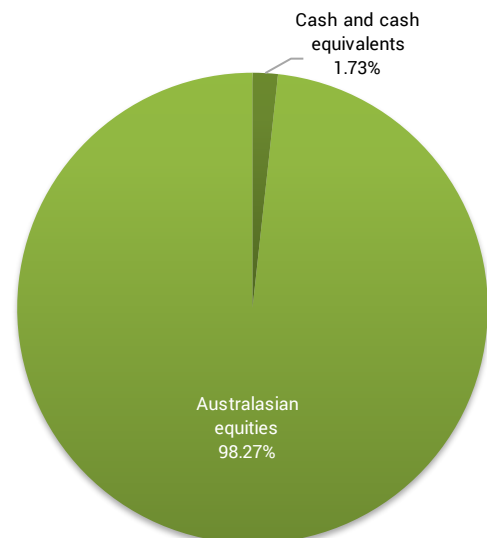
Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$487 (that is -4.87% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total loss after tax of -\$499 for the year.

Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 60%. The actual hedging level can be anywhere in the 0% - 120% range. As at 30 June 2022, 60.04% of the fund's foreign currency exposure was hedged.
