The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets




Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$1,403 (that is 14.03% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total return after tax of \$1,391 for the year.

Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 60%. The actual hedging level can be anywhere in the 0% - 120% range. As at 31 March 2022, 58.28% of the fund's foreign currency exposure was hedged.
