What is the purpose of this update?

This document tells you how SuperLife¹⁰⁰ has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

SuperLife¹⁰⁰ invests in growth assets. Designed for investors that are comfortable with the value of their investment fluctuating. Negative annual returns may occur once in every 2-4 years on average.

Total value of the fund: \$229,848,558

Number of investors in the fund: 18,128

The date the fund started: 15 September 2013

What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

*From 9 November 2016, the total fund charges changed to an estimated 0.69% per annum of the fund's net asset value and the administration fee reduced to \$30 per annum.

Example of how this applies to an investor


Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$750 (that is 7.50% of her initial \$10,000). Jess paid other charges of \$33². This gives Jess a total return after tax of \$717 for the year.

Notes

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 1 year and 8 months of market index returns.
- 2 This is made up of 11 months of \$2.75 per month (when the administration fee was \$33 per annum) and 1 month of \$2.50 (when the administration fee was \$30 per annum).
