## SuperLife KiwiSaver scheme

## **UK Shares/Property Fund**

This fund update was first made publicly available on 28 February 2017.

#### What is the purpose of this update?

This document tells you how the UK Shares/Property Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this fund**

The UK Shares/Property Fund is designed to provide a return (after tax, fees and other expenses) that reflects the after-tax return on the international share and property markets, managed from a UK investor's perspective.

#### What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.



#### Other specific risks

There are other risks that may increase the risk to returns for investors, which are not reflected in the risk indicator. These risks include active management risk. In particular, while SuperLife KiwiSaver scheme's philosophy is that a passive approach to investing will deliver better long-term results, we make some active management decisions. There is a risk that this may result in the fund achieving a return that is lower than the investment objective for the fund.



#### Example of how this applies to an investor


Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$233 (that is -2.33% of her initial \$10,000). Jess paid other charges of \$33<sup>2</sup>. This gives Jess a total loss after tax of -\$266 for the year.

#### Notes

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 1 year and 8 months of market index returns.
- 2 This is made up of 11 months of \$2.75 per month (when the administration fee was \$33 per annum) and 1 month of \$2.50 (when the administration fee was \$30 per annum).
- 3 The top 10 investments listed in the table exclude current assets and current liabilities, as a result do not sum to 100%.
