


# Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$126 (that is -1.26% of her initial \$10,000). Jess paid other charges of \$30. This gives Jess a total loss after tax of -\$156 for the year.
