# What is the purpose of this update?

This document tells you how the NZ Bonds Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Invests in New Zealand bonds and designed to reflect the return (before tax, fees and other expenses) on the New Zealand bond market.

# How has the fund performed?




# Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$418 (that is 4.18% of her initial \$10,000). Jess paid other charges of \$30. This gives Jess a total return after tax of \$388 for the year.
