# What is the purpose of this update?

This document tells you how the Australian Dividend Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. # What are the risks of investing?

Risk indicator for the Australian Dividend Fund<sup>1</sup>



GST is included in the fund charges set out above.


## **Example of how this applies to an investor**

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$2,218 (that is -22.18% of her initial \$10,000). Jess paid other charges of \$30. This gives Jess a total loss after tax of -\$2,248 for the year.

# **Material changes**
