This fund update was first made publicly available on 29 October 2020.

What is the purpose of this update?

This document tells you how the S&P/NZX NZ Government Bond Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The S&P/NZX NZ Government Bond Fund invests in New Zealand bonds and designed to track the return (before tax, fees and other expenses) on the S&P/NZX NZ Government Bond Index.

Total value of the fund: \$261,711

Number of investors in the fund: 30

What are the risks of investing?

Risk indicator for the S&P/NZX NZ Government Bond Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


Example of how this applies to an investor

Jess had \$10,000 in the fund on 15 July 2020 and did not make any further contributions. On 30 September 2020, Jess received a return after fund charges were deducted of \$172 (that is 1.72% of her initial \$10,000). Jess paid other charges of \$5 (Jess received statements and other SuperLife communications electronically and was not charged the paper statements fee). This gives Jess a total gain after tax of \$167 for the 2 months and 15 days.
