Fund update for the quarter ended 31 December 2021

This fund update was first made publicly available on 14 February 2022.

What is the purpose of this update?

This document tells you how the SuperLife Balanced Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests in a mix of income and growth assets and designed for investors that want a balanced investment option. Negative annual returns may occur once in every 5-7 years on average.

Total value of the fund: \$64,718,105

Number of investors in the fund: 1,216

The date the fund started: 23 February 2009

What are the risks of investing?

Risk indicator for the SuperLife Balanced Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$917 (that is 9.17% of her initial \$10,000). Jess paid other charges of \$30. This gives Jess a total return after tax of \$887 for the year.

Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 68.54%. The actual hedging level can be anywhere in the 0% - 120% range. As at 31 December 2021, 67.54% of the fund's foreign currency exposure was hedged.

Notes

- 1 We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges.
- 2 The administration fee in the year to 31 March 2021 is stated net of an income tax deduction that was applied in calculating your PIE tax payable (the deduction was paid to us). On 1 April 2021, we stopped doing this this means the total fee you will now pay us will be lower.
