### Fund update for the quarter ended 30 June 2021

This fund update was first made publicly available on 28 July 2021.

## What is the purpose of this update?

This document tells you how the Overseas Nongovernment Bonds Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this fund**

Invests in international bonds and designed to reflect the return (before tax, fees and other expenses) on international non-government bond markets of developed economies.

## What are the risks of investing?

#### Risk indicator for the Overseas Non-government Bonds Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


## How has the fund performed?


## Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$126 (that is 1.26% of her initial \$10,000). Jess paid other charges of \$30. This gives Jess a total return after tax of \$96 for the year.

#### **Currency hedging**

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 100% (although the actual hedging level may differ from this because of cash flow and market movements). As at 30 June 2021, 99.90% of the fund's foreign currency exposure was hedged.

#### **Notes**

- 1 We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges.
- 2 The administration fee in the year to 31 March 2021 is stated net of an income tax deduction that was applied in calculating your PIE tax payable (the deduction was paid to us). On 1 April 2021, we stopped doing this this means the total fee you will now pay us will be lower.
- 3 The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
