Fund update for the quarter ended 30 June 2022

This fund update was first made publicly available on 27 July 2022.

What is the purpose of this update?

This document tells you how the SuperLife Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests mostly in growth assets and is designed for investors that want a growth investment option. Negative annual returns may occur once in every 3-5 years on average.

Total value of the fund: \$42,866,788

Number of investors in the fund: 1,289

The date the fund started: 16 September 2013

What are the risks of investing?

Risk indicator for the SuperLife Growth Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$897 (that is -8.97% of her initial \$10,000). Jess paid other charges of \$30. This gives Jess a total loss after tax of -\$927 for the year.

Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 69%. The actual hedging level can be anywhere in the 0% - 120% range. As at 30 June 2022, 65.07% of the fund's foreign currency exposure was hedged.

- 1 We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges.
