### What is the purpose of this update?

This document tells you how SuperLife<sup>80</sup> has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this fund**

SuperLife<sup>80</sup> invests mostly in growth assets, with a small amount of income assets. Designed for investors that have a long-term investment timeframe. Negative annual returns may occur once in every 3 - 5 years on average.

## What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

\* From 9 November 2016, the total fund charges changed to an estimated 0.60% per annum of the fund's net asset value.

The Scheme has an entry fee. This fee is to meet the costs of transferring your money into the Scheme from a UK pension scheme. It will be calculated as our estimate of those costs and will be agreed with you before we start the transfer process.

### Example of how this applies to an investor


Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$794 (that is 7.94% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$734 for the year.

### Notes
