This Investment Update was first made publicly available on 13 February 2017.

What is the purpose of this update?

This document tells you how SuperLife^{Age Steps} - Age 50 has performed and what fees were charged. The document will help you to compare the stage with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this stage

SuperLife^{Age Steps} automatically adjusts the proportion of your investment in income and growth assets depending on your age. As you get older, the proportion of your investment in higher risk growth assets will be reduced, lowering the expected size of the ups and downs in the value of your investment. This option may be suitable if you are saving for retirement (assumed to be age 65), and assumes you will continue to invest your savings and spend them over your retirement period.

Your SuperLife^{Age Steps} - Age 50 investment will be allocated 25% to SuperLife^{Income} and 75% to SuperLife¹⁰⁰ (which are managed funds this stage invests in).

What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the stage's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.





How has the stage performed?

Annual return graph

* From 9 November 2016, the total fund charges changed to 0.61% per annum of the stage's net asset value.

The Scheme has an entry fee. This fee is to meet the costs of transferring your money into the Scheme from a UK pension scheme. It will be calculated as our estimate of those costs and will be agreed with you before we start the transfer process.

Example of how this applies to an investor


Jess had \$10,000 in the stage at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$663 (that is 6.63% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$603 for the year.
