# **SuperLife**Income

This fund update replaces the fund update for the quarter ended 31 December 2017 that was first made publicly available on 26 January 2018. Note 2 has been updated to refer to 7 December 2017 changes to the total management and administration charges.

#### Fund update for the quarter ended 31 December 2017

This fund update was first made publicly available on 5 February 2018.

### What is the purpose of this update?

This document tells you how SuperLife<sup>Income</sup> has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

# **Description of this fund**

SuperLife<sup>Income</sup> invests in income assets. Designed for investors that want an investment in New Zealand and international fixed interest. Negative annual returns may occur once in every 7-10 years on average.

# What are the risks of investing?

Risk indicator for SuperLife<sup>Income 1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


# How has the fund performed?

#### **Example of how this applies to an investor**


Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$396 (that is 3.96% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$336 for the year.

#### **Notes**

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 9 months of market index returns.
- 2 On 7 December 2017, the total management and administration charges changed to 0.56% per annum. As a result, the total fund charges will be different in the year to 31 March 2018.
