

# Fund Update

## SuperLife UK pension transfer scheme

### Australian Shares Fund

For the quarter ended 30 June 2017.

This fund update was first made publicly available on 25 July 2017.

### What is the purpose of this update?

This document tells you how the Australian Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The Australian Shares Fund is designed to provide a return (after tax, fees and other expenses) that reflects the after-tax return on the Australian share market.

### What are the risks of investing?

#### Risk indicator for the Australian Shares Fund <sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.

### Other specific risks

There are other risks that may increase the risk to returns for investors, which are not reflected in the risk indicator. These risks include investment management risk. In particular, while the SuperLife UK pension transfer scheme's philosophy is that a passive approach to investing will deliver better long-term results, we make some active management decisions. There is a risk that this may result in the fund achieving a return that is lower than its investment objective.

There is also a risk that UK tax law changes and as a result the SuperLife UK pension transfer scheme loses its recognised overseas pension scheme (ROPS) status. There is also a risk that the UK's rules for ROPS change. We will not be liable for any loss you may suffer if this happens.

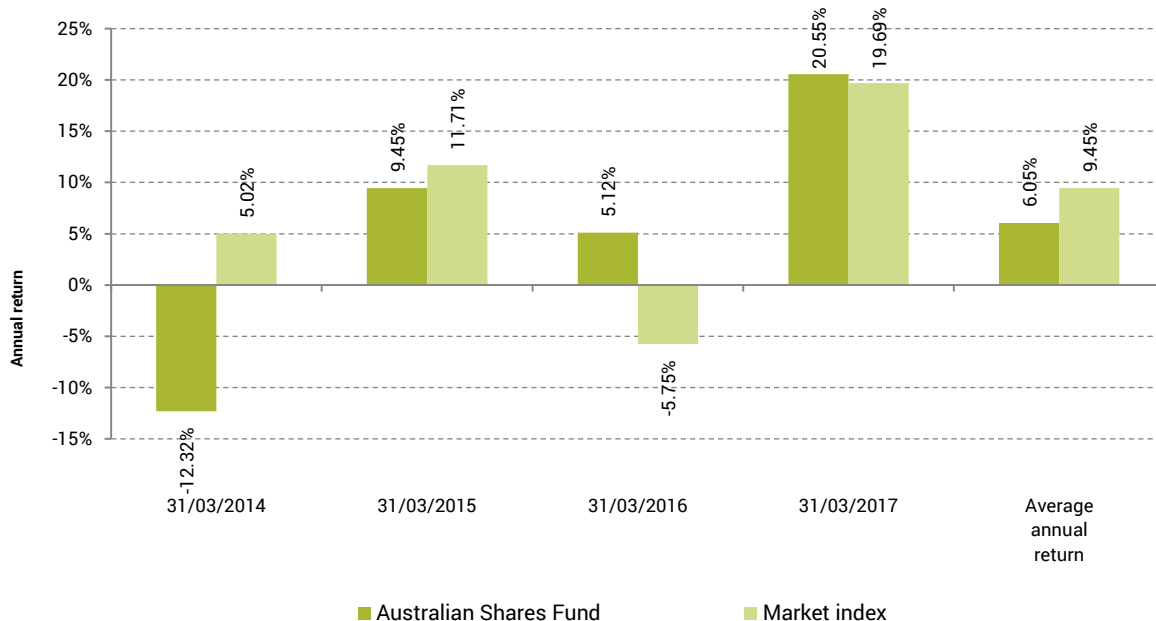

### How has the fund performed?

### Annual return graph

Small differences in fees and charges can have a big impact on your investment over the long term.

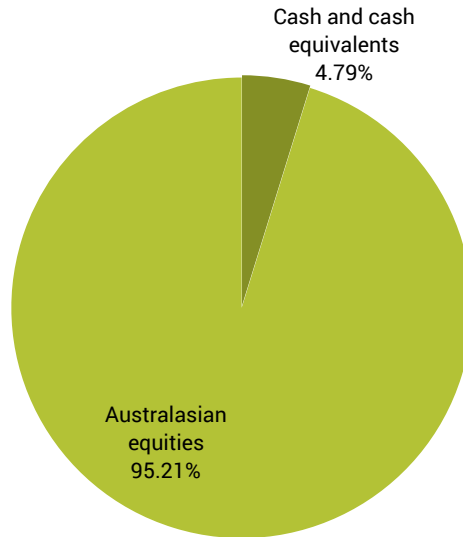
### Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$1,864 (that is 18.64% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$1,804 for the year.

### Notes

- 2 On 9 November 2016, the total management and administration charges changed to 0.54% per annum. As a result, the total fund charges will be different in the year to 31 March 2018.
