This fund update was first made publicly available on 24 October 2017.

What is the purpose of this update?

This document tells you how the US Mid Cap ETF Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The US Mid Cap ETF Fund invests in the Smartshares Exchange Traded Funds' US Mid Cap Fund.

Total value of the fund: \$5,616

Number of investors in the fund: 1

What are the risks of investing?

Risk indicator for the US Mid Cap ETF Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

This risk indicator is not a guarantee of a fund's future performance. The risk indicator is based on the returns data for 5 years to 30 September 2017. While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.

Other specific risks

There are other risks that may increase the risk to returns for investors, which are not reflected in the risk indicator. These risks include underlying fund tracking risk. In particular, the fund invests in an exchange traded fund, which is designed to track the return on a specific index. Tracking difference may occur when the weighting of each of the financial products included in the index changes, and the fund that tracks the index is not able to exactly match that change. There is a risk that this may result in the fund achieving a return that is lower than the index being tracked by the fund.

There is also a risk that UK tax law changes and as a result the SuperLife UK pension transfer scheme loses its recognised overseas pension scheme (ROPS) status. There is also a risk that the UK's rules for ROPS change. We will not be liable for any loss you may suffer if this happens.




How has the fund performed?

Example of how this applies to an investor


Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$1,287 (that is 12.87% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$1,227 for the year.

Notes

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 3 years of market index returns.
- 2 On 9 November 2016, the total management and administration charges changed to 0.52% per annum. As a result, the total fund charges will be different in the year to 31 March 2018.
- 3 The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
