What is the purpose of this update?

This document tells you how the NZ Property ETF Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

What are the risks of investing?

Risk indicator for the NZ Property ETF Fund²



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a riskfree investment, and there are other risks that are not captured by this rating.

This risk indicator is not a guarantee of a fund's future performance. The risk indicator is based on the returns data for 5 years to 30 June 2018. While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.

Other specific risks

There are other risks that may increase the risk to returns for investors, which are not reflected in the risk indicator. These risks include the risk that changes to the UK's rules for recognised overseas pension schemes (**ROPS**) limit your ability to withdraw your investments or affect the UK tax you pay on your investment. We will not be liable for any loss you may suffer if this happens.

There is also underlying fund tracking risk. In particular, the fund invests in an exchange traded fund, which is designed to track the return on a specific index. Tracking difference may occur when the weighting of each of the financial products included in the index changes, and the fund that tracks the index is not able to exactly match that change. There is a risk that this may result in the fund achieving a return that is lower than the index being tracked by the fund.


How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$813 (that is 8.13% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$753 for the year.

Notes

- 1 The NZ Property ETF Fund does not currently have any investors. The information in this document sets out our estimates as to how the NZ Property ETF Fund would have performed and what fees would have been charged if it had investors. These estimates are based on our experience in respect of the NZ Property ETF Fund in the other SuperLife managed investment schemes.
- 2 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 2 years and 5 months of market index returns.
- 3 The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
