## What is the purpose of this update?

This document tells you how SuperLife<sup>Income</sup> has performed and what fees were charged. The document will help you to compare the fund with other funds. ## **Description of this fund**

Invests in income assets. Designed for investors that want an investment in New Zealand and international fixed interest. Negative returns may occur once in every 7-10 years on average.

## What are the risks of investing?

Risk indicator for SuperLife<sup>Income 1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


## **Example of how this applies to an investor**

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$289 (that is 2.89% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$229 for the year.

#### **Notes**

1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years.
