What is the purpose of this update?

This document tells you how the US Mid Cap Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The US Mid Cap Fund invests in the Smartshares Exchange Traded Funds' Smartshares US Mid Cap ETF.

Total value of the fund: \$39,345

Number of investors in the fund: 4

What are the risks of investing?

Risk indicator for the US Mid Cap Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



How has the fund performed?


Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$2,893 (that is 28.93% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$2,833 for the year.

Material changes

Notes

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 9 months of market index returns.
- The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
- The Smartshares US Mid Cap ETF is also managed by Smartshares. As a result, the table lists the individual assets of the Smartshares US Mid Cap ETF as if they were individual assets directly held by the fund.
