# What is the purpose of this update?

This document tells you how SuperLife Growth has performed and what fees were charged. The document will help you to compare the fund with other funds. # **Description of this fund**

Invests mostly in growth assets. Designed for investors that want a growth investment option. Negative annual returns may occur once in every 3-5 years on average.

# Risk indicator for SuperLife Growth

Administration fee

Small differences in fees and charges can have a big impact on your investment over the long term.

### **Example of how this applies to an investor**

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$740 (that is 7.40% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$680 for the year.

#### **Currency hedging**

The fund's foreign currency exposure may be hedged to the New Zealand dollar, and hedging levels will vary between 0% and 110%. As at 31 March 2019, 99.57% of the fund's foreign currency exposure was hedged.
