What is the purpose of this update?



GST is included in the fund charges set out above.


Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$415 (that is 4.15% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$355 for the year.
