What is the purpose of this update?



GST is included in the fund charges set out above.


Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$396 (that is -3.96% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total loss after tax of -\$456 for the year.

Notes

1 The administration fee is stated net of an income tax deduction applied in calculating your PIE tax payable (the deduction is paid to us). The relevant gross fee is calculated using a 28% tax rate.
