## Fund update for the quarter ended 30 June 2020

This fund update was first made publicly available on 28 July 2020.

## What is the purpose of this update?

This document tells you how the SuperLife Income Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this fund**

Invests in income assets and designed for investors that want an investment in New Zealand and international fixed interest. Negative annual returns may occur once in every 7–10 years on average.

## Risk indicator for the SuperLife Income Fund



## How has the fund performed?

GST is included in the fund charges set out above.


#### Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$332 (that is 3.32% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$272 for the year.

#### **Currency hedging**

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 100%. The actual hedging level can be anywhere in the 0% - 120% range. As at 30 June 2020, 99.40% of the fund's foreign currency exposure was hedged.
