# What is the purpose of this update?



GST is included in the fund charges set out above.


# Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$2,039 (that is - 20.39% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total loss after tax of -\$2,099 for the year.

#### **Currency hedging**

The fund's foreign currency exposure may be hedged to the New Zealand dollar, and hedging levels will vary between 0% and 110%. As at 31 March 2020, 72.53% of the fund's foreign currency exposure was hedged.
