# What is the purpose of this update?



GST is included in the fund charges set out above.


# Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$1,194 (that is - 11.94% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total loss after tax of -\$1,254 for the year.
