### What is the purpose of this update?

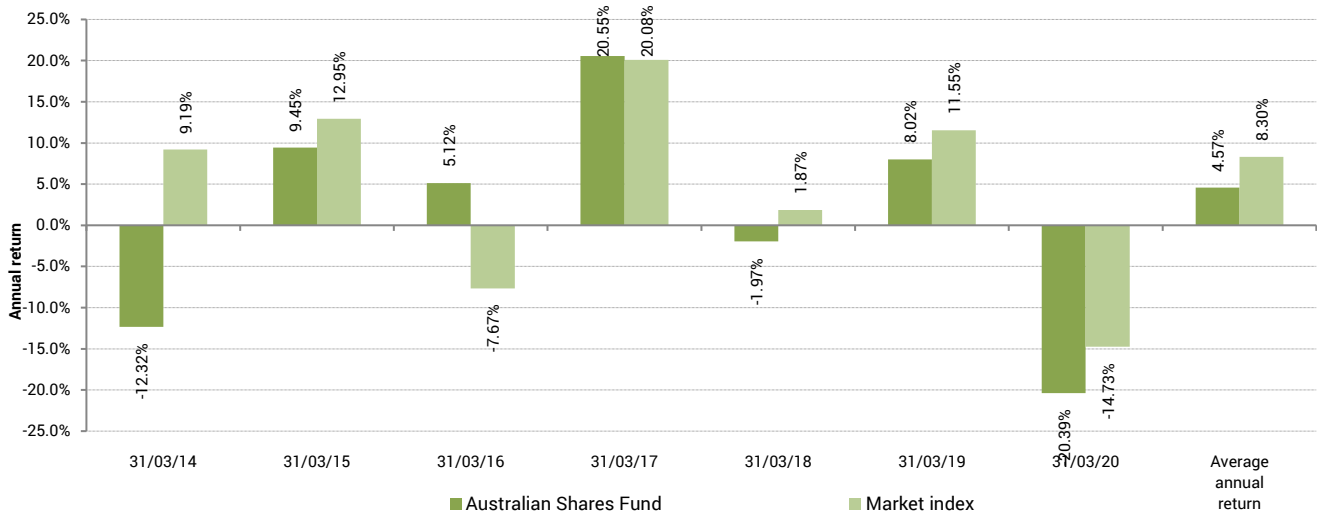

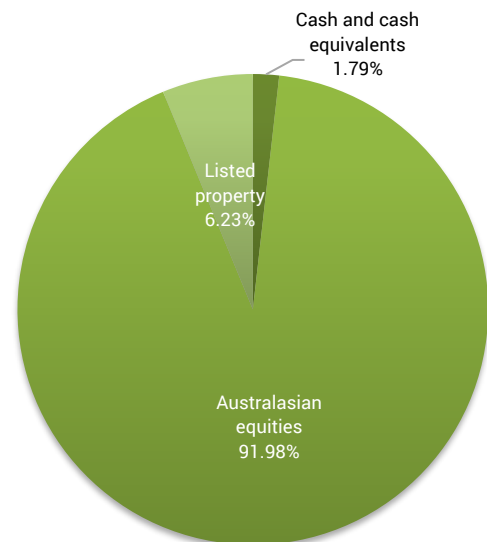
## Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of -\$1,041 (that is -10.41% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total loss after tax of -\$1,101 for the year.

### Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 75%. The actual hedging level can be anywhere in the 0% - 120% range. As at 30 September 2020, 71.53% of the fund's foreign currency exposure was hedged.
