## What is the purpose of this update?

This document tells you how the Emerging Markets Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. ## **Description of this fund**

Invests in international shares and designed to track the return (before tax, fees and other expense) on the FTSE Emerging Markets All Cap China A Inclusion Index.

## What are the risks of investing?

Risk indicator for the Emerging Markets Fund


## How has the fund performed?


## **Example of how this applies to an investor**

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$2,550 (that is 25.50% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$2,490 for the year.
