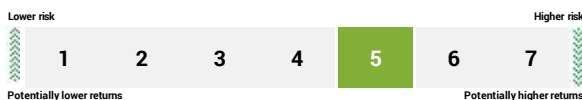
Description of this fund

What are the risks of investing?

Risk indicator for the Overseas Shares Fund

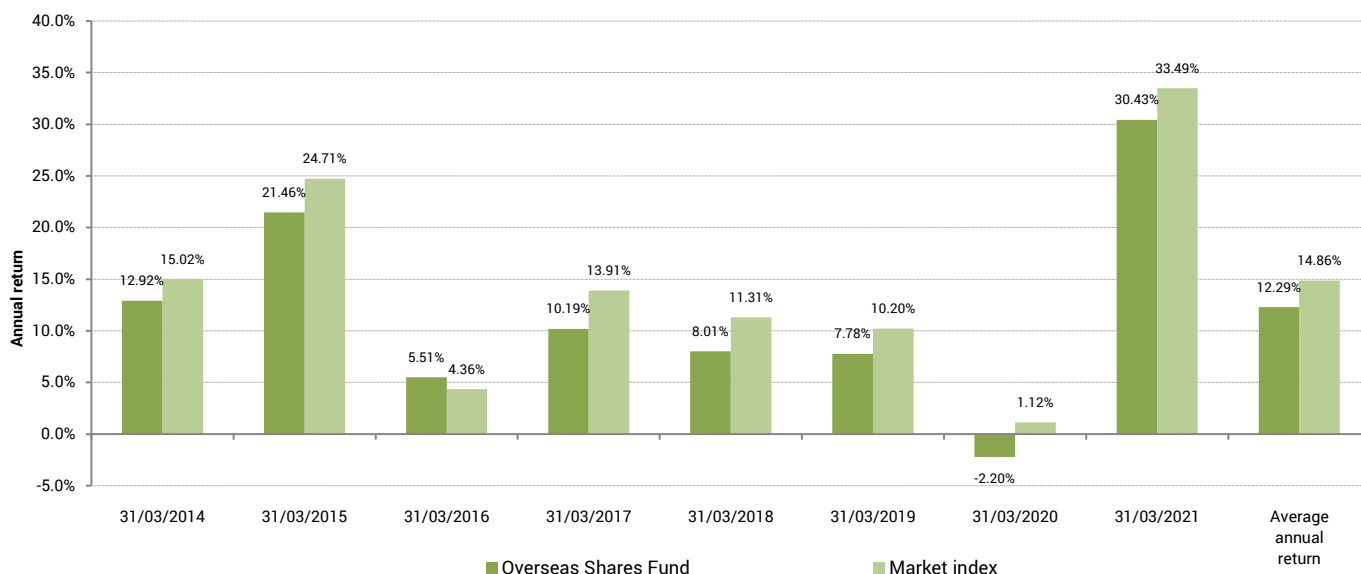
How has the fund performed?

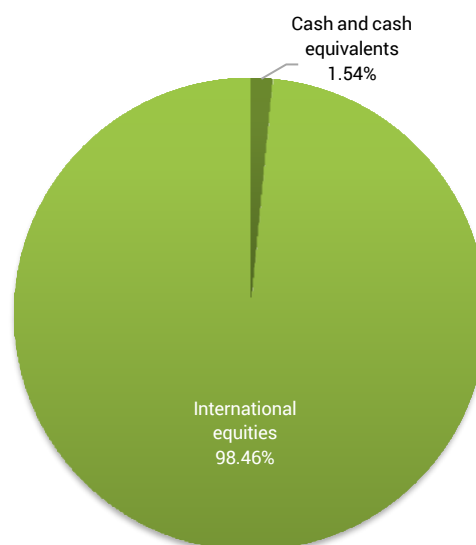
Example of how this applies to an investor

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$2,753 (that is 27.53% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$2,693 for the year.

- 2 We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges.
