What is the purpose of this update?

This document tells you how the Australian Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. What are the risks of investing?

Risk indicator for the Australian Shares Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

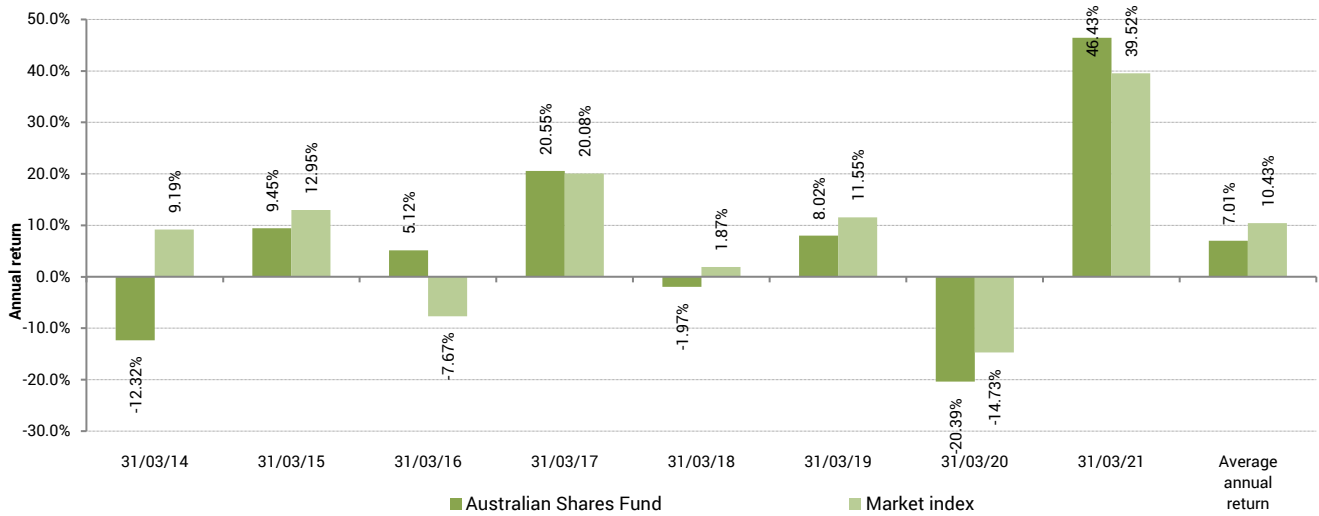
How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.

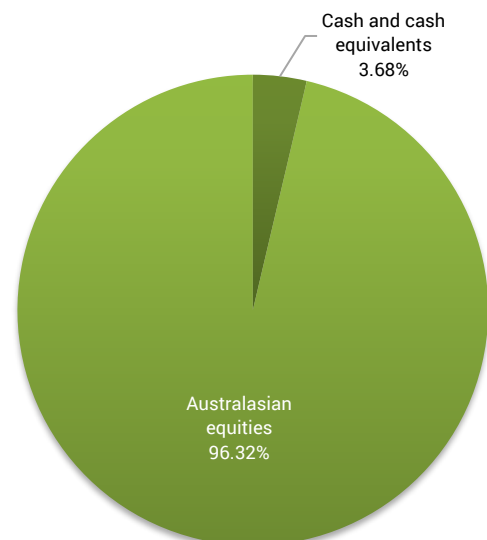
Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$2,926 (that is 29.26% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$2,866 for the year.

Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 70%. The actual hedging level can be anywhere in the 0% - 120% range. As at 30 September 2021, 59.0% of the fund's foreign currency exposure was hedged.

- 1 On 1 April 2021, the fund's total fund charges increased to 0.70%.
- 2 We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges.
