Fund update for the quarter ended 31 December 2022

What is the purpose of this update?

This document tells you how the Ethica Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Designed for investors that want a balance between stability of returns and growth of their investment over the long term. Provides exposure to a diverse selection of global companies and income assets that align with our Responsible Investment Policy. We exclude assets that do not meet our socially responsible investment standards, and increase or decrease exposure to companies based on their environmental, social and governance (ESG) factors.

What are the risks of investing?

Risk indicator for the Ethica Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

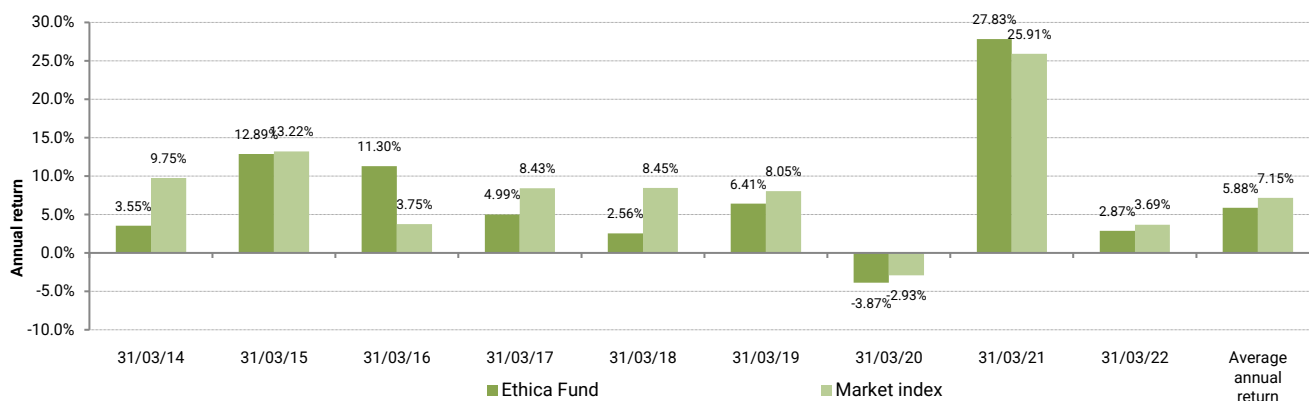

The market index return is a composite of benchmark index returns, weighted for the fund's target investment mix (also known as target asset allocation). 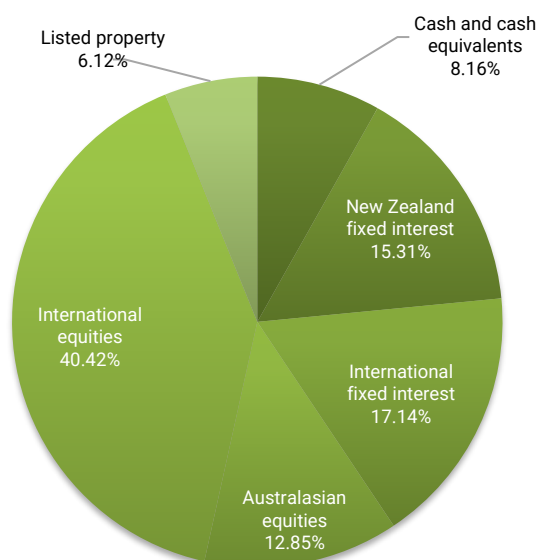
Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted but before tax of \$-1286 (that is -12.86% of Jess's initial \$10,000). Jess paid other charges of \$60. This gives Jess a total loss after tax of \$-1343 for the year.

Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 75.50% of the fund's foreign currency exposure. The actual hedging level can be anywhere in the 0% - 120% range. As at 30 December 2022, 76.22% of the fund's foreign currency exposure was hedged.
