What is the purpose of this update?


Note that even the lowest category does not mean a riskfree investment, and there are other risks that are not captured by this rating.


Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$1,360 (that is -13.60% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total loss after tax of -\$1,420 for the year.
