## SuperLife Income Fund

#### Fund update for the quarter ended 30 June 2022

This fund update was first made publicly available on 27 July 2022.

## What is the purpose of this update?

This document tells you how the SuperLife Income Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this fund**

Invests in income assets and is designed for investors that want an investment in New Zealand and international fixed interest. Negative annual returns may occur once in every 7-10 years on average.

Total value of the fund: \$4,001,335

Number of investors in the fund: 89

## What are the risks of investing?

#### Risk indicator for the SuperLife Income Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


## How has the fund performed?


#### **Example of how this applies to an investor**

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$563 (that is -5.63% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total loss after tax of -\$623 for the year.

The top 10 investments make up 42.47% of the fund's net asset value.

## **Currency hedging**

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 100% of the fund's foreign currency exposure. The actual hedging level can be anywhere in the 0% - 120% range. As at 30 June 2022,100% of the fund's foreign currency exposure was hedged.
