# Australian Top 20 Fund

This is a replacement fund update dated 27 July 2022, which replaces the previous fund update dated 3 May 2022. The table in the "What fees are investors charged?" section has been updated to show the corrected Manager's basic fee, total management and administration charges and total fund charges that were actually charged to investors in the year ending 31 March 2022. They were previously incorrectly published as 0.10% lower than the actual fund charges, as they did not include a 0.10% fee increase that took effect on 1 April 2021.


Note that even the lowest category does not mean a riskfree investment, and there are other risks that are not captured by this rating.


## Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$1,214 (that is 12.14% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$1,154 for the year.
