# **Global Aggregate Bond Fund**

This is a replacement fund update dated 27 July 2022, which replaces the previous fund update dated 3 May 2022. The table in the "What fees are investors charged?" section has been updated to show the corrected Manager's basic fee, total management and administration charges and total fund charges that were actually charged to investors in the year ending 31 March 2022. They were previously incorrectly published as 0.10% lower than the actual fund charges, as they did not include a 0.10% fee increase that took effect on 1 April 2021.

#### Fund update for the guarter ended 31 March 2022

This fund update was first made publicly available on 27 July 2022.

# What is the purpose of this update?

This document tells you how the Global Aggregate Bond Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

# **Description of this fund**

The Global Aggregate Bond Fund invests in international bonds and is designed to track the return (before tax, fees and other expenses) of the Bloomberg Global Aggregate Bond Index, 100% hedged to the New Zealand dollar.

## What are the risks of investing?

#### Risk indicator for the Global Aggregate Bond Fund<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.




## **Example of how this applies to an investor**

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$562 (that is -5.62% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total loss after tax of -\$622 for the year.

#### **Currency hedging**

The fund invests in the Smartshares Global Aggregate Bond ETF which invests in the iShares Core Global Aggregate Bond UCITS ETF NZD Hedged (Acc), which foreign currency exposure is hedged to the New Zealand dollar.

# **Notes**

- We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges.
