SuperLife Age Steps - Age 20 ¹

This is a replacement fund update dated 27 July 2022, which replaces the previous fund update dated 3 May 2022. The table in the "What fees are investors charged?" section has been updated to show the corrected Manager's basic fee, total management and administration charges and total fund charges that were actually charged to investors in the year ending 31 March 2022. They were previously incorrectly published as 0.10% lower than the actual fund charges, as they did not include a 0.10% fee increase that took effect on 1 April 2021.

Investment update for the quarter ended 31 March 2022

This investment update was first made publicly available on 27 July 2022.

What is the purpose of this update?

This document tells you how SuperLife Age Steps - Age 20 (the stage) has performed and what fees were charged. The document will help you to compare the stage with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this stage

SuperLife Age Steps automatically sets the proportion of your investment in income and growth assets based on your age. As you get older, the proportion of your investment in more volatile growth assets will be reduced, lowering the expected size of the ups and downs in the value of your investment. This option may be suitable if you are saving for retirement (assumed to be age 65), and assumes you will continue to invest your savings and spend them over your retirement period.

Your SuperLife Age Steps - Age 20 investment will be allocated 5% to income assets and 95% to growth assets.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the stage's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

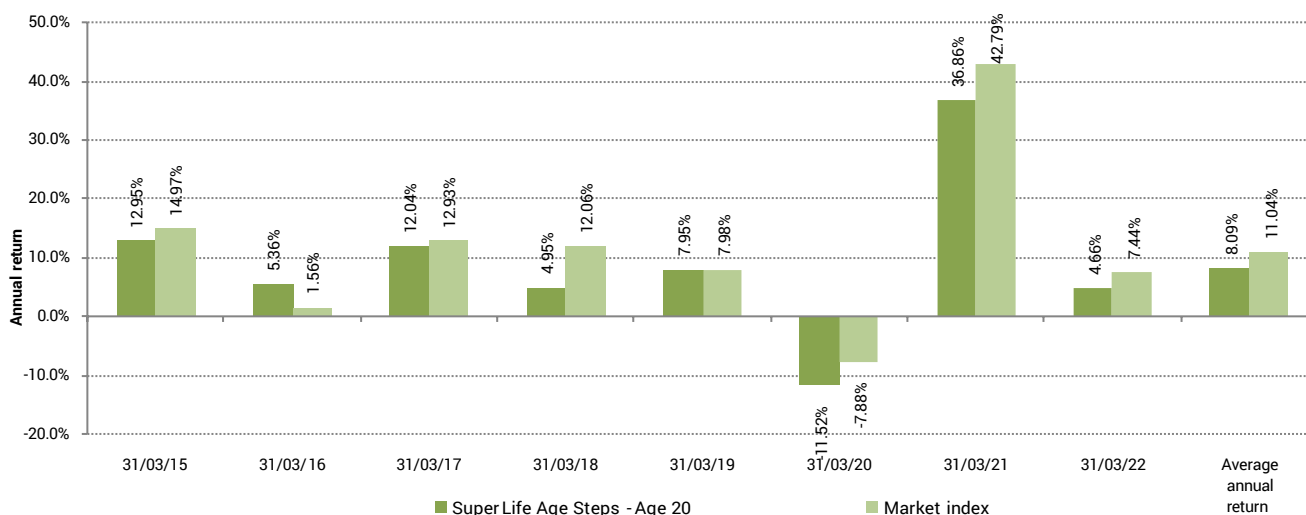
Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

Annual return graph



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 March 2022.

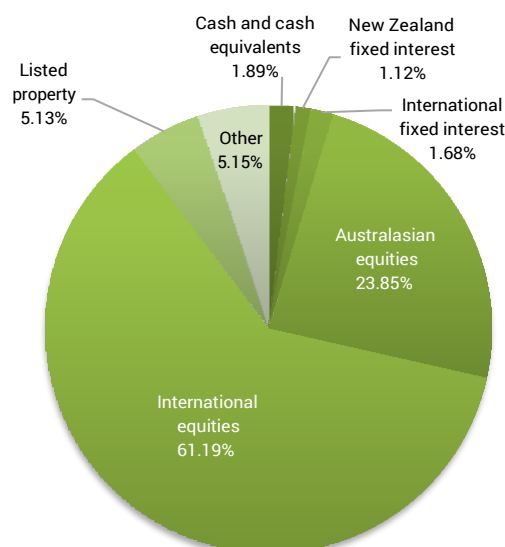
Example of how this applies to an investor

Jess had \$10,000 in the stage at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$466 (that is 4.66% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total return after tax of \$406 for the year.

Notes

- 1 SuperLife Age Steps - Age 20 does not currently have any investors. The information in this document sets out our estimates as to how SuperLife Age Steps - Age 20 would have performed and what fees would have been charged if it had investors. These estimates are based on our experience in respect of SuperLife Age Steps - Age 20 in the other SuperLife managed investment schemes.
- 2 The fund charges for SuperLife Age Steps are estimates based on the target investment mix of underlying funds for each age step. The fund charges actually charged may differ from the estimate if the actual investment mix of underlying funds for your investment differs from the target because of market movements.
- 3 We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges.
- 4 The 'other' category refers to an investment in infrastructure. The underlying investments are infrastructure securities listed in developed countries.
