

# SuperLife UK pension transfer scheme

## Global Property Fund

This is a replacement fund update dated 8 April 2024, which replaces the previous fund update dated 31 July 2023. ### Fund update for the quarter ended 30 June 2023

### What is the purpose of this update?

This document tells you how the Global Property Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### What are the risks of investing?

#### Risk indicator for the Global Property Fund

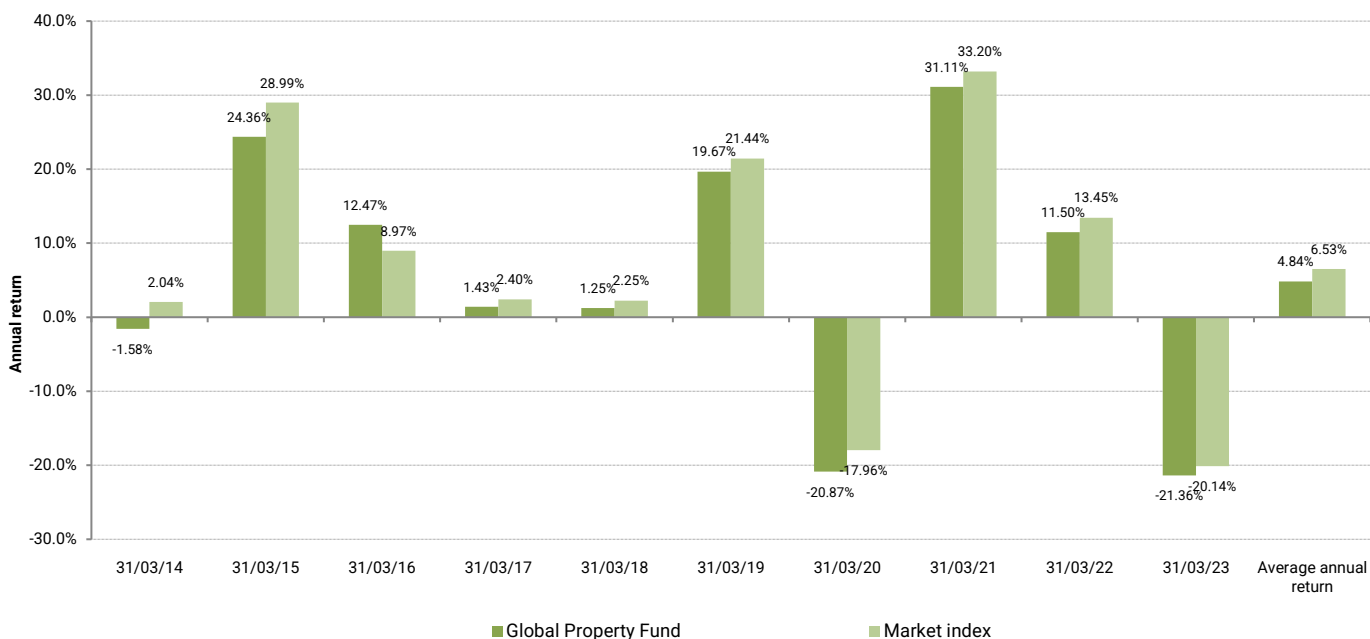
### How has the fund performed?

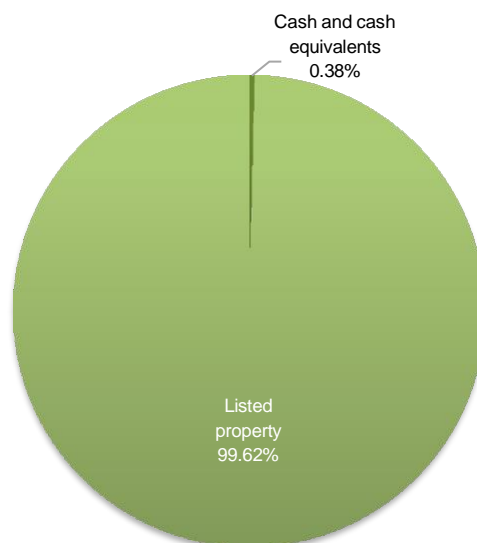
## Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$437 (that is -4.37% of her initial \$10,000). Jess paid other charges of \$60. This gives Jess a total loss after tax of -\$497 for the year.

## Currency hedging

As at 30 June 2023 the fund's exposure to assets denominated in foreign currencies was 75.21%, of which 98.45% was hedged. This means the fund's unhedged foreign currency exposure was 1.17% of the net asset value of the fund. ## Notes

- 1 These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
