This fund update was first made publicly available on 3 November 2016.

What is the purpose of this update?

This document tells you how the NZ Bond ETF Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The NZ Bond ETF Fund invests in the Smartshares Exchange Traded Funds' NZ Bond Fund.

Total value of the fund: \$180,352

Number of investors in the fund: 40

What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.



Other specific risks

There are other risks that may increase the risk to returns for investors, which are not reflected in the risk indicator. These risks include investment management risk. In particular, the investment manager for the fund buys and sells financial products based on its own assessment of what is happening in the market. There is a risk that the investment manager selects investments that result in the fund achieving a return that is lower than the investment objective for the fund.

Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

Jess had \$10,000 in the fund on 12 November 2015 and did not make any further contributions. On 30 September 2016, Jess received a return after fund charges were deducted of \$419 (that is 4.19% of her initial \$10,000). Jess paid other charges of \$12 (Jess received statements and other SuperLife communications electronically and was not charged the paper statements fee). This gives Jess a total return after tax of \$407 for the 10 months and 19 days.

Notes

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 4 years and 1 month of market index returns.
- 2 To the extent that fund charges involve amounts that are fixed as percentages of the net asset value, those amounts have been used to calculate the fund charges. To the extent that amounts are not fixed, a best estimate of amounts has been used.
- Estimates have been used to calculate this amount. In particular, we have made estimates for the costs charged by the supervisor and custodians, the costs charged by the other funds we invest in, and our regulatory and compliance costs. These estimates are based on our experience in respect of other SuperLife managed investment schemes we manage and assume that the fund's actual investment mix will be consistent with the target investment mix set out in the Statement of Investment Policy and Objectives for SuperLife workplace savings scheme.
- 4 You will only be charged this fee if you choose to receive statements and other SuperLife communications in paper form.
