## SuperLife<sup>Age Steps</sup> - Age 60

### Investment update for the quarter ended 30 September 2017

This investment update was first made publicly available on 24 October 2017.

### What is the purpose of this update?

This document tells you how SuperLife<sup>Age Steps</sup> - Age 60 has performed and what fees were charged. The document will help you to compare the stage with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this stage

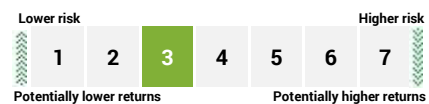
SuperLife<sup>Age Steps</sup> automatically adjusts the proportion of your investment in income and growth assets depending on your age. As you get older, the proportion of your investment in more volatile growth assets will be reduced, lowering the expected size of the ups and downs in the value of your investment. This option may be suitable if you are saving for retirement (assumed to be age 65), and assumes you will continue to invest your savings and spend them over your retirement period.

Your SuperLife<sup>Age Steps</sup> - Age 60 investment will be allocated 42.5% to SuperLife<sup>Income</sup> and 57.5% to SuperLife<sup>100</sup> (which are managed funds this stage invests in).

### What are the risks of investing?

#### Risk indicator for SuperLife<sup>Age Steps</sup> - Age 60 <sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the stage's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

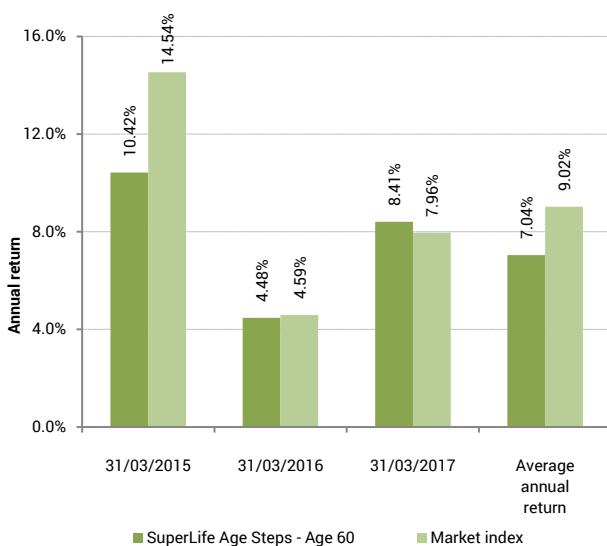


## How has the stage performed?

### Annual return graph



This shows the return after fund charges and tax for each year ending 31 March since the stage started. The last bar shows the average annual return since the stage started, up to 30 September 2017.

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing money and transferring it to a KiwiSaver scheme other than the SuperLife KiwiSaver scheme). Small differences in fees and charges can have a big impact on your investment over the long term.

### Example of how this applies to an investor

Jess had \$10,000 in the stage and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$721 (that is 7.21% of her initial \$10,000). Jess paid other charges of \$16<sup>5</sup> (Jess received statements and other SuperLife communications electronically and was not charged the paper statements fee). This gives Jess a total return after tax of \$705 for the year.

## Notes

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator as SuperLife<sup>Age Steps – Age 60</sup> invests in SuperLife<sup>Income</sup> and SuperLife<sup>100</sup> (together with the NZ Cash Fund), which have not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of SuperLife<sup>Age Steps – Age 60</sup>. The risk indicator for SuperLife<sup>Age Steps – Age 60</sup> uses 1 year of market index returns for SuperLife<sup>Income</sup> and SuperLife<sup>100</sup>.
- 2 On 9 November 2016, the total management and administration charges changed to 0.49% per annum. As a result, the total fund charges will be different in the year to 31 March 2018.
- 3 On 9 November 2016, the administration fee changed to \$12 per annum. As a result, the amount set out in the fees table is made up of 4 months of \$1 per month (when the administration fee was \$12 per annum) and 8 months of \$2.75 per month (when the administration fee was \$33 per annum).
- 4 You will only be charged this fee if you choose to receive statements and other SuperLife communications in paper form.
- 5 This is made up of 2 months of \$2.75 per month (when the administration fee was \$33 per annum) and 10 months of \$1.00 (when the administration fee was \$12 per annum).
