## SuperLife<sup>Income</sup>

#### Fund update for the quarter ended 30 June 2018

This fund update was first made publicly available on 25 July 2018.

## What is the purpose of this update?

This document tells you how SuperLife<sup>Income</sup> has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this fund**

Invests in income assets. Designed for investors that want an investment in New Zealand and international fixed interest. Negative returns may occur once in every 7-10 years on average.

Total value of the fund: \$49,937,738

Number of investors in the fund: 1,091

The date the fund started: 15 September 2013

### What are the risks of investing?

#### Risk indicator for SuperLife<sup>Income 1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

#### How has the fund performed?



Small differences in fees and charges can have a big impact on your investment over the long term.


#### **Example of how this applies to an investor**

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$176 (that is 1.76% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total return after tax of \$164 for the year.
