#### Fund update for the quarter ended 31 December 2019

## What is the purpose of this update?

This document tells you how the Australian Top 20 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## What are the risks of investing?

Risk indicator for the Australian Top 20 Fund<sup>1</sup>


#### How has the fund performed?

GST is included in the fund charges set out above.


## **Example of how this applies to an investor**

Jess had \$10,000 in the fund and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$1,713 (that is 17.13% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total return after tax of \$1,701 for the year.

## **Material changes**

There have been no material changes to the nature of the SuperLife workplace savings scheme, the investment objectives and strategy of the fund, or the management of the scheme over the quarter ended 31 December 2019.

## **Notes**

- Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 9 months of market index returns.
- The Smartshares Australian Top 20 ETF is also managed by Smartshares. As a result, the table lists the individual assets of the Smartshares Australian Top 20 ETF as if they were individual assets directly held by the fund.
